I accept Keep Rockland Beautiful (KRB) & Hackensack Riverkeeper's (HRI) Liability Release: *

I understand that my participation in this cleanup is voluntary and at my sole risk without expectation of payment/remuneration of any type. I, for good and valuable consideration, hereby release Keep Rockland Beautiful, Inc. & Hackensack Riverkeeper's employees, board members, event volunteers, it's director, and any affiliated or related entity, from and against any and all claims, suits, proceedings, liabilities and losses previously, now and hereafter incurred arising from or relating to any events, acts, omissions or other occurrences which caused or causes me to sustain damage to my person or property in connection with this activity, including but not limited to set up, clean up and all other matters pertaining to said activity.

I realize that there are several ways that I could potentially hurt myself if I am not careful or choose a task that I am not capable of doing. For example, I might choose to canoe in streams or rivers that may contain strong currents or uneven bottoms, presenting added risk. I realize that my participation in any activities during this event, including canoeing, is strictly voluntary and that I assume the risks associated with these activities.

I hereby indemnify and hold harmless Keep Rockland Beautiful, Inc. & Hackensack Riverkeeper's employees, board members, event volunteers, it's director, and any affiliated or related entity, from and against any and all claims, suits proceedings, investigations, liabilities and losses arising from or relating to my participation at any Keep Rockland Beautiful & HRI related cleanup event, other than such claims as may be due to or caused by the acts or omissions of Keep Rockland Beautiful, Hackensack Riverkeeper and their employees.

I understand that parents, guardians & chaperones will be signing on behalf of all minors accompanying them. As a Parent and/or Natural Guardian of the below listed Child(ren), I agree to indemnify myself for the supervision of listed Child(ren) during their participation in the cleanup on the date listed below, including but not limited to, all injuries, sickness, and death.

I understand and accept Keep Rockland Beautiful (KRB) & Hackensack Riverkeeper's Photo Release agreement:

I give full permission for KRB, HRI, and affiliated participants to capture video, audio, images & any other personal identification characteristics to be used in any manner, in perpetuity, in any and all media, now known or hereafter devised, including the right to edit, delete, dub and/or fictionalize such materials. By signing below, I waive any & all rights to compensation, ownership of such materials. Photos and videos will be used only to promote KRB, HRI and their environmental programs and will not be sold to third parties or used commercially.

I agree to abide by KRB & HRI's COVID Safety Guidelines: *

I understand that I am to abide by state requirements and all KRB & HRI safety protocol during a cleanup event, including the following:

- I will notify KRB & HRI and refrain from participating in a cleanup if I experienced COVID symptoms or have tested positive for COVID within 5 days of the event.
- The morning of the cleanup, I will pre-screen myself to make sure I am not experiencing any COVID symptoms and do not have a temperature over 100 degrees. If so, I will notify KRB & HRI immediately and refrain from participating in cleanup.
- I will maintain 6 feet of social distancing and wear a mask at all times when at the KRB/HRI shed and/or at group check-in at a Cleanup Event. At all other times, I will do my best to maintain social distancing and wear a mask when within 6 ft. of others.
- I will print and have all volunteers on my team sign this KRB & HRI waiver/agreement. I (if under 18, must be signed by a parent or guardian) before arrival at a group check-in to avoid crowding and ensure a quick and efficient check-in process.
