

Keep Rockland Beautiful MCWA Cleanup Safety, Liability and Photo Agreement

I accept KRB's Liability Release:

I understand that my participation and that of the minors accompanying me in this cleanup and waterways exploration and education event is voluntary, without expectation of payment/remuneration of any type and that I will not be covered under the Keep Rockland Beautiful (KRB) or Garnerville Holding Company insurance policies. I understand this is a release of liability & by signing my name below I forfeit my right to sue Keep Rockland Beautiful, KRB employees, board members, volunteers & participating entities - Garnerville Holding Company, Inc., their directors, employees and tenants; Rockland County Soil & Water Conservation District; Rockland County Conservation & Service Corps - for any injury or loss as a result of my participation and volunteerism.

KRB's COVID & Safety Guidelines:

I understand that I am to abide by state and county requirements and all KRB safety protocol during a cleanup event, including the following:

- I will notify KRB and refrain from participating in a cleanup, if I experienced COVID symptoms or have tested positive for COVID within 5 days of the event.
- I will print and have all volunteers on my team sign this KRB waiver/agreement before arrival at a group check-in to avoid crowding and ensure a quick and efficient check-in process. (For anyone under 18, this must be signed by a parent or guardian)
- I will review and share KRB's Tips for a Safe & Successful Cleanup with all my team members before a cleanup.

Keep Rockland Beautiful's (KRB) Photo Release: (You can choose to opt out of this provision. Be sure to indicate that you do not want photos taken/used by writing "No Photos" next to your signature.)

I give full permission for KRB and affiliated participants to capture video, audio, images & any other personal identification characteristics to be used in any manner, in perpetuity, in any and all media, now known or hereafter devised, including the right to edit, delete, dub and/or fictionalize such materials. By signing below, I waive any & all rights to compensation, ownership of such materials. Photos and videos will be used only to promote KRB and its environmental programs and will not be sold to third parties or used commercially.
